Protocol E15 Shipping Documentation Greenhouse Labelled PCP Products

Effective January 1, 2024 Protocol E15 (formerly E16) will change to incorporate requirement for agri-retailers to verify certification of all greenhouse customer ordering agri-chemicals.

Background:

CropLife Canada launched the Protected Agricultural Stewardship Standards to address water quality concerns related to greenhouse product use. As a result, a group of impacted stakeholders agreed to work towards the development of a credible protected agriculture pesticide lifecycle stewardship program. The approach focuses on adherence to a national standard that supports compliance with registered pesticide label directions and the mitigation of risks associated with crop protection tools, fostering the health and safety of people and the environment.

Protected Ag Operator using closed loop irrigation/chemigation systems are referred to as Category 1 PA Operators. Effective January 1, 2024, all Category 1 PA Operators will need to be certified under the program to access PCP products labelled for greenhouse use.

Protected Ag Operator not using closed loop irrigation/chemigation systems are referred to as Category 2 PA Operators. They are not required to be audited, but effective January 1, 2024 they will need to sign a Declaration of Category 2 Protected Ag Operation Waiver to access greenhouse labelled PCP registration crop protection products.

Distributors and retailers of greenhouse labelled PCP registration crop protection products will be required to verify an operator's status prior to selling/shipping products or confirm a waiver has been completed.

Effective January 1, 2024, Protocol E15 will be revised as follows (see red text for amendments)

Between January 1, 2024 to June 30, 2024 protect agriculture operators will have either:

- Temporary Protected Ag Certificate (with an expiration date of June 30, 2024); or
- Full Protected Ag Certificate (Certificate of Compliance or Certificate of Excellence); or
- Declaration of Category 2 Protected Ag Operation Waiver.

All temporary Protected Ag Certificates expire on June 30, 2024. After June 30, 2024 protect agriculture operators will have either:

- Full Protected Ag Certificate (Certificate of Compliance or Certificate of Excellence); or
- Declaration of Category 2 Protected Ag Operation Waiver.

As a retailer, please document the operator's certification number (certificates contain numbers) on shipping documents or have on file a copy of the waiver.

- 2. I acknowledge that I have read the definitions for Category 1 and Category 2 Protected Ag Operations and that our operation falls into Category 2.
- 3. I agree to notify the Agrichemical Warehousing Standards Association (AWSA) in advance of any changes in use, scope or operation that changes the category for our operation.

Definitions:

Protected Ag: Protected Agriculture (PA) refers to crops that are grown under structures such as: greenhouses, shade houses, hoop houses, high tunnels, warehouses etc...

Category 1 Protected Ag Operation: All PA operations, of any crop, using closed-loop chemigation (drench) systems. A closed system is one where any excess chemigation liquid delivered to the crop is captured via trough, drainage tile, or other similar conveyance system, rather than allowed to percolate into the ground. Warehouse production structures and freight container growing operations with no subterranean plumbing and continuous flooring are excluded from Category 1.

Category 2 Protected Ag Operation: All PA operations, of any crop, using open chemigation systems where excess chemigation liquid is not captured. Warehouse production structures and freight container growing operations with no subterranean plumbing and continuous flooring are considered Category 2 even if they have closed-loop chemigation systems.

Shipping/Receiving Requirements:

Effective January 1, 2024 all ag-retailers will be required to verify all Category 1 Operators' Protected Ag certification number prior to shipping/selling greenhouse labelled PCP registered products.

Effective January 1, 2024 all ag-retailers will be require to have a waiver on file for all Category 2 Protected Ag Operators prior to shipping/selling greenhouse labelled PCP registered products.
